- RESOLUTION NO. 65

Budget Modifications

NOW, THEREFORE, BE IT RESOLVED:

Sec. 1. That the Supervisor is hereby authorized to make the following modification to the 2024 Town Budget:

\$440 from A.8810.402 Cemetery Contractual Equipment Repairs to
A.8810.200 Cemetery Equipment

Sec. 2 That this resolution shall take effect immediately.

- RESOLUTION NO. 66 Appoint Seasonal Laborers – Cemetery Operations

WHEREAS, there is a need for seasonal laborers for cemetery operations; and

WHEREAS, the Superintendent of Highways has recommended re-hiring seasonal laborers John P. Duthoy, Kevin Young and Leonard Natiello; and

WHEREAS, the Superintendent of Highways has recommended hiring seasonal laborers Cody DeToy and Ruth Kruppner.

NOW, THEREFORE, BE IT RESOLVED:

Sec. 1. That the Town Board of the Town of Sweden does hereby appoint John P. Duthoy, Leonard Natiello, Kevin Young, Cody DeToy and Ruth Kruppner for seasonal cemetery operations not to exceed 40 hours per week each and not to exceed 112 hours per week in total.

Sec. 2. That this appointment does not constitute an offer of permanent employment or any benefits that are normally attached to permanent appointments.

Sec. 3. That the rate of pay will be \$15.00 per hour.

Sec. 4. That the term of appointment for John P. Duthoy, Leonard Natiello, Cody DeToy and Kevin Young will begin on or after April 22, 2024 and end on or before October 18, 2024.

Sec. 5. That the term of appointment for Ruth Kruppner will begin on or after April 22, 2024 and end on or before May 17, 2024.

Sec. 6. That this resolution shall take effect immediately.

- RESOLUTION NO. 67 Appoint Seasonal Highway Laborer – Duthoy

WHEREAS, there is a vacancy in the seasonal laborer position for the Town of Sweden highway summer operations.

NOW, THEREFORE, BE IT RESOLVED:

Sec. 1. That the Town Board of the Town of Sweden does hereby appoint John P. Duthoy as a seasonal laborer for Town of Sweden highway department beginning on or after April 22, 2024 and ceasing on or before October 18, 2024, not to exceed 360 hours for the season.

Sec. 2. That the appointment does not constitute an offer of permanent employment or any benefits that are normally attached to permanent appointments.

Sec. 3. That the rate of pay will be \$18.00 per hour.

Sec. 4. That this resolution shall take effect immediately.

- RESOLUTION NO. 68 Appoint Seasonal Laborers – Park

WHEREAS, the Buildings and Grounds department has recommended the re-appointment of Benjamin May, Dale Taber and Brian Garske as Seasonal Laborers for the Sweden Town Park for the 2024 summer season.

NOW, THEREFORE, BE IT RESOLVED:

Sec. 1. That the Town Board of the Town of Sweden does hereby appoint Benjamin May, Dale Taber and Brian Garske as Seasonal Laborers at a rate of pay of \$15.00 per hour, not to exceed 28 hours per week, beginning on or after April 22, 2024 and ending on or before October 4, 2024.

Sec. 2. That this appointment does not constitute an offer of permanent employment or any benefits that are normally attached to permanent appointments.

Sec. 3. That this resolution shall take effect immediately.

- RESOLUTION NO. 69 Authorize Race Management Solutions Proposal

WHEREAS, the Town Board of the Town of Sweden has received a proposal for the Harvest Fest 5K Race registration and timing from Race Management Solutions.

NOW, THEREFORE BE IT RESOLVED:

Sec. 1 That the Town Board of the Town of Sweden accepts the proposal from Race Management Solutions for registration, timing and other related services for the Harvest Fest 5K Race on September 14, 2024.

Sec. 2 That the Supervisor is authorized to sign the proposal and any other necessary documents.

Sec. 3. That this resolution shall take effect immediately.

- RESOLUTION NO. 70 Appoint Member to Board of Assessment Review - Dobbertin

WHEREAS, there is a vacancy on the Board of Assessment Review due to the resignation of Douglas VanDetta; and

WHEREAS, the vacancy has been duly advertised.

NOW, THEREFORE, BE IT RESOLVED:

Sec. 1. That the Town Board of the Town of Sweden does hereby appoint David Dobbertin to the Board of Assessment Review and that he will be required to complete the necessary training and certification.

Sec. 2. That the term of membership is April 10, 2024 to September 30, 2027.
