A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, May 28, 2024.

Town Board Members present were Supervisor Patricia Hayles, Councilperson Scott Maar, Councilperson Tyler Sharpe, Councilperson Adam Staskiewicz, and Councilperson Gary Sullivan. Also present were Finance Director Leisa Strabel, Superintendent of Highways Brian Ingraham, Town Attorney Jim Bell, and Town Clerk Karen Sweeting.

Visitors present were Wayne Zyra and Michael Myers representing the Sweden Community Foundation.

Supervisor Hayles called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence especially with this week having Memorial Day, to remember all of those who have lost family members in the service to our country and ask for sympathies to Dr. Allen Edwards who serves our Town very well with the rabies clinic, who recently lost his wife Vicky.

## PRIVILEGE OF THE FLOOR

Michael Myers addressed the Board and explained that he is a strong advocate for recreation in the Town of Sweden. Mr. Myers thanked the board for their part in partnering with and supporting the Foundation's recreation initiatives that will enhance recreation opportunities in the Town of Sweden.

Wayne Zyra thanked the board for their consideration on the fishing deck – resolution on the agenda. If the resolution is approved, they can move forward on the contractual work, selection of colors, and installation. Mr. Zyra reminded the board of the upcoming Challenger Baseball game on Saturday beginning at 9 am at Nietopski Field on Redman Road and the celebration of life for Jack Milner at the Oliver Middle School at 1 pm.

## CORRESPONDENCE:

No correspondence noted.

## REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Superintendent of Highways Brian Ingraham reported they are nearing the end of the construction phase on Crestview Drive, completed drainage work on Gary Drive, and prepared LaDue Road between Route 19 and West Sweden Road for paving. Crews built a parking lot for a new lodge at County owned Knollwood Lodge. They assisted the Town of Hamlin with a project and continue mowing at the cemeteries.

Town Attorney Jim Bell provided updates to the sale of 133 State Street, hoping to close by the end of summer.

Supervisor Hayles announced a water information meeting on June 25, 2024. Letters were sent to those within the proposed district. The lunch program has been moved to the Sweden Clarkson Community Center. A few minor issues were addressed. Excess kitchen equipment from 133 State Street will be sold by bid – resolution on the agenda.

Supervisor Hayles attended the workers compensation pool meeting with Finance Director Leisa Strabel. There are thirteen appointments scheduled for the Assessment Grievance being held today, walk ins are allowed. The sewer issues at the Seymour Library are being resolved. The Town of Clarkson performed the outside work, and the inside work has been put on hold until after summer programming. Mrs. Hayles met with Superintendent Brian Ingraham and Finance Director Leisa Strabel to discuss a joint grant application with the Village of Brockport for a new sewer truck.

Supervisor Hayles attended the Supervisor's Association meeting, which is a valuable resource. They discussed food truck certifications.

Supervisor Hayles stated that the Town will absorb approximately \$1,900 in materials and labor for the walkway to the fishing deck. If the Sweden Community Foundation raises excess funds for the project, the Town will be reimbursed these costs. *The contract is subject to the Supervisor's approval.* \*\*Amendments made at the meeting of June 25, 2024\*\*

Supervisor Hayles has met with Lyle Stirk, Building/Code Enforcement to discuss consistent enforcement of the existing code for the benefit of the Town. Thirty-six violations have been issued this year, compared to sixteen last year. We want to inform residents and are working on an article for the Snapshots. Comprehensive Plan updates will be considered for 2025.

Supervisor Hayles will be attending the Memorial Day Celebration at Oliver Middle School and will be meeting with Adam Shade in the Buildings and Grounds Department to discuss additional training.

Councilperson Staskiewicz reported that the Summer Scoreboard is out and available, registration has begun. Baseball and soccer leagues are going well and are planning the July 3<sup>rd</sup> event, working on securing more food vendors. Summer camp staff training is underway, and the nutrition program is going well. The new Director of Buildings and Grounds, Adam Shade, is working out well.

Councilperson Sullivan commented on Adam Shade and his new position and will be meeting with him to discuss long and short-term projects and the goals of the department. Soccer and baseball are up and running, Lodge rentals are strong, skate park and dog park are busy. Seasonal staff are in place and the banners are all up and displayed. Challenger Baseball starts Saturday, June 1<sup>st</sup>.

Councilperson Maar had no report.

Councilperson Sharpe reported that the flag placement was a huge success, 900 flags were placed by approximately 30 volunteers. Harvest Festival planning continues.

- <u>Sec. 1.</u> That the Town Board of the Town of Sweden does hereby approve the construction of a two-person, above-ground mausoleum in Section D of Lakeview Cemetery, completely at the cost of applicants Jeffrey and Julie Rothenburgh.
- Sec. 2. That the Rothenburghs must fund an endowment of 10% of the cost of the mausoleum and foundation, that said endowment will be held in an interest-bearing trust account of the Town of Sweden.
- Sec. 3. That the Town Board of the Town of Sweden accepts the Woodside Granite Industries 20-year warranty for the Foundation.
- <u>Sec. 4.</u> That the Town Board of the Town of Sweden expects to receive an adequate warranty for the Mausoleum structure.
- <u>Sec. 5.</u> That permission to install the Mausoleum is granted on the condition that all Lakeview Cemetery fees are paid and the endowment funds received.

Ordering a Public Hearing Regarding the Adoption of Local Law No. 2 of 2024 –

Proposed Amendments to Sweden Town Code – Chapter 73 Cemeteries

- WHEREAS, recommendations have been made to change several sections of Chapter 73 Cemeteries of the Sweden Town Code; and
- WHEREAS, the Sweden Town Board is desirous of adopting the proposed changes by Local Law.

#### NOW, THEREFORE BE IT RESOLVED:

- Sec. 1. The Town Board of the Town of Sweden shall hold a public hearing at the Town Hall, 18 State Street, Brockport, New York on the 25th day of June 2024 at 6:00 pm to hear all interested persons for or against the adoption of Local Law No. 2 of 2024 proposed amendments to Chapter 73 Cemeteries of the Sweden Town Code.
- Sec. 2. The proposed amendments are as follows:

Chapter 73-1. Rules and regulations.

A. (3) In purchasing more than one grave, full purchase price must be paid for one grave and the balance shall be paid in full within 30 days or graves will be subject to resale.

(10) All full body interments during the week (Monday through Friday) must be in the cemetery by 2:00-1:00 p.m., Eastern Standard Time. After 2:00 p.m., 1:00 p.m., an overtime fee as set by the Town Board will be charged. No interment will be allowed after 3:30 p.m. 3:00 p.m., Eastern Standard Time...
(11) All interments on Saturday, Sundays and Town of Sweden observed holidays, including floating holidays, will be charged double the interment fee an overtime fee.

(15) All casket graves are required to have a concrete vault or liner. All fault setups, including Wilbert Ways, will be at the discretion of the Superintendent of Highways.

(21) No vault or mausoleum shall be above ground without the permission of the Town Board, and only in such locations as it approves.

(22) The Town Board will approve no mausoleum for construction unless a sufficient endowment is set up to provide adequate income to maintain the structure.

(24) Only one family monument shall be allowed on a plot. A minimum of six plots is required to allow for a family monument. All family monuments shall conform to established plan in regard to size, material, and location, *and must be approved by the Superintendent of Highways*.

<u>Sec. 3.</u> The Town Clerk is authorized and directed to cause a notice of the public hearing to be published in the Town's official newspapers, as required by law.

<u>Sec.4.</u> This Resolution shall take effect immediately.
