A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, June 25, 2024.

Supervisor Hayles called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence for our first responders and all those in the service.

PUBLIC HEARING

At 6:00 p.m. Supervisor Hayles called to order the public hearing. The purpose of the public hearing was to hear all persons for or against the adoption of a Local Law amending Chapter 73, Cemeteries, of the Sweden Town Code.

Supervisor Hayles waived the reading of the legal notice.

Supervisor Hayles explained that the amendments include changes to the hours, internment times, and discontinuing placement of mausoleums.

No comments. The Public Hearing was closed at 6:10 p.m.

PRESENTATION

Supervisor Hayles introduced Leigha Walker and her mother Haley. Leigha performed CPR at the local Subway Restaurant and saved a man's life.

Supervisor Hayles invited County Legislator Jackie Smith to come forward. Legislator Smith said on behalf of the Monroe County Legislature, we recognize Leigha Walker for her heroic actions and thanked her for her service to the community. We will always be indebted to you.

Supervisor Hayles read the following Certificate of Recognition:

- WHEREAS, on Sunday, June 9, 2024, Leigha Walker, a Holley High School Senior, faced a life-or-death situation at the Subway Restaurant in the Town of Sweden; and
- WHEREAS, Leigha was working an early shift when a man having a medical emergency crashed his truck into a support beam of the restaurant's entryway and hangover; and
- WHEREAS, she immediately called 911 and then rushed outside to check the driver who was unconscious in a locked vehicle; and
- WHEREAS, Leigha procured a rod that was used to smash open a window and after others helped pull the man from the truck, Leigha began performing CPR until emergency responders could take charge.

NOW, THEREFORE BE IT RESOLVED, that the Town Board of the Town of Sweden recognizes Leigha Walker for her calm, quick, and life-saving response, particularly in light of her young age, that the entire community is grateful, not only for her proficiency at CPR, but her willingness to take charge in a chaotic situation.

Supervisor Hayles invited Christopher Martin representing the Brockport Fire Department to come forward. Mr. Martin said they don't get to do this very often; we don't get to meet the helpful residents that assist at the scene and have the outcome that Leigha had. The victim is home and recovering, early CPR is the key to it all. Thank you, Leigha.

Brockport Fire Chief Medina, on behalf of the Brockport Fire District, presented Leigha with the "Life Saving Award".

WATER DISTRICT PRESENTATION

Supervisor Hayles introduced Jim Oberst and Scott Mattison from MRB Group.

Jim Oberst shared information for a proposed water district involving LaDue Road, West Sweden Road and Swamp Road. He detailed the funding and district formation processes. Scott Mattison detailed the proposed project scope, potential cost projections, and project implementation.

Q & A – open to residents:

Resident Mike Rockow

- Q length of process?
- A potentially up to 3 years
- Q What does it mean, the Town owns the water system?
- A Town still owns the pipes in the ground and has a 40-year lease with MCWA who is responsible for maintaining the system and all the repairs.
- Q Previous district on Route 19, favorable grant monies, this one may be more favorable?
- A Both eligible for poverty level grant funding, most optimal funding limit you can receive from Rural Development.

Resident Mark Rabjohn

- Q Each parcel pays same amount?
- A In Sweden it is calculated by benefit basis for district formation and each parcel (including vacant parcels) is assessed one Equivalent Dwelling Unit (EDU)
- Q See a decrease in homeowners' insurance due to fire protection (hydrants) being provided?
- A No quantifiable information

Resident Tom Widzinski

- Q What is a meter pit?
- A A meter located near the road instead of at the house. (This is required for homes that are a greater distance away from the road.)
- Q Guideline document for homeowners for the installation of the water line from the road to the house?
- A MCWA provides that information
- Q Enforcement of residents disabling current well?
- A MCWA has options and requirements for well separation

Resident John Dobrowsky

- Q One-time connection fee?
- A One-time fee to MCWA to set up the account
- Q Can residents install their portion of the water line ahead of time?
- A At your own risk since the process is lengthy, and you want to make sure the project progresses, but no reason you can't contact MCWA for the details.
- Q Why infrastructure money was not used?
- A Town only received a small amount compared to the cost of water district formation and installation

Resident Bernice Lachman

- Q Clarification of proposed district on LaDue Road?
- A LaDue Road will go from Lake Road to the county line

Resident Ed Anderson

- Q Owns property within another water district, why the difference in annual costs?
- A Costs based on what Rural Development may fund. May fluctuate due to parcels splitting or joining or actual costs vs. proposed costs.

Resident John Eeckhout

- Q What determines the side of the road for installation of the water main?
- A Where connections will be made to existing water mains, other existing utilities, environmental features, and overall constructability

Resident Mike Schuff

- Q Clarify cost for new customers, if opt out, still pay?
- A Yes, if in the district you will pay the annual debt service however no commodity charge

Resident Nancy Hyde

- Q If a resident owns more than one property, house on one parcel, barn on another parcel or vacant do they pay for each parcel?
- A Yes, per parcel (tax account number)
- Q Can Rural Development take the money back
- A No, it is a legally binding contract

Resident Peter Englert

- Q Projected cost for installation on Swamp Road near Iroquois Rock, what if it costs more due to rock?
- A The estimated project cost accounts for rock. You cannot go over the amount on the petition. Test bores would be done to determine the quantity of rock.

Resident Mike Rockow

- Q What determines an EDU compared to other Towns?
- A The Town of Sweden decided that one tax account equals one EDU consistent with previous water districts in Sweden. It is up to each town to determine.

Resident Annette Seyler

- Q Parcel not on the frontage of LaDue Road not charged?
- A Correct

Resident Pam Rockow

- Q What is the testing for quantity and quality of the water?
- A A sample is taken and tested for coliform and E. coli. Rural Development likes to see sampling done on each road within a proposed district.

Resident Emily Bej

- Q Confirm if well is kept, one-time fee for separation?
- A Yes, that is one option, a one-time fee and an inspection every five years to make sure it is kept separate.
- Q What is the source for water in Sweden?
- A Monroe County Water Authority and the source is Lake Ontario.

MRB Group is looking for volunteers for the water testing. Information will be mailed to all parcels in the district, residents can sign up now.

REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Superintendent of Highways Brian Ingraham reported they finished the CHIPS project on LaDue Road and are beginning road work in Northview Subdivision.

Town Attorney Jim Bell reported several pending code violations.

Finance Director Leisa Strabel reported on the workers compensation audit. The Town received notification that the assessments are back to 100%, which is important for borrowing. No kitchen equipment items sold and will be going to auction this week.

Town Attorney Jim Bell provided updates relative to the sale of 133 State Street.

Councilperson Staskiewicz reported that baseball season is coming to a close, soccer is going well, and planning for the July 3rd event and August car show are going well. Senior programming and food programming are going well. The Fall brochure should be out before the end of August.

Councilperson Sullivan reported that Buildings and Grounds and the Town Park are in full swing – Challenger Baseball and soccer programs. A large group from Holley School District utilized the Splash Pad. The drainage is better on Nietopski Field.

Councilperson Maar reported that the Seymour Library Foundation has been busy with planning the Garden Tour. BOCES continues to meet at the library – bilingual story time. Summer reading begins June 27th with Luigi's Ice Cream Truck. Landscaping at the library needs maintenance. A contractor has been hired and they discussed a new design for 2025. Paving of the parking lot should begin after Labor Day. Bids will go out soon for the bathroom remodel. Budget draft has been prepared and will be presented in August.

Councilperson Sharpe reported that the cemeteries are busy with maintenance. Requesting to check the structural integrity of the mausoleum, roof and windows. The Harvest Festival planning continues. The Cornell Cooperative program is going well.

Supervisor Hayles reported several calls from residents from the Chateau relative to the zoning requirements. Discussions with Town Attorney and Planning Board Chairman. Mrs. Hayles attended the Planning Board meeting held on June 10th and will be attending the Monroe County EMS meeting on June 26th to hear the current state of emergency services in the county. The Village Board will be holding a public hearing on the rezoning application for 133 State Street.

Supervisor Hayles attended the Memorial Day celebration at Oliver Middle School. She met with insurance brokers and consultants along with the incoming Finance Director and current Finance Director, Leisa Strabel. Mrs. Hayles thanked Leisa Strabel for her hard work over the last 20+ years. She has kept the Town fiscally stable, and Mrs. Hayles extended her personal thanks for all her knowledge and history and recognized Leisa for all she has done.

Supervisor Hayles announced that a developer has approached the Town to build single family homes. Discussions will continue.

- Sec. 1. That the Sweden Town Board does hereby designate the proposed Local Law as a Type II action.
- <u>Sec. 2.</u> That this resolution shall take effect immediately.
 - RESOLUTION NO. <u>102</u>
 Adopt Local Law No. 2 of 2024 Amending Sweden Town Code – Chapter 73 Cemeteries
- WHEREAS, the Town Board of the Town of Sweden has determined that it is in the best interests of the Town of Sweden for certain amendments to be made to the Sweden Town Code Chapter 73 Cemeteries; and
- WHEREAS, a duly advertised Public Hearing was held by the Town Board at the Town Hall, 18 State Street, Brockport, New York on June 25, 2024 at 6 PM, to hear all

persons interested in the adoption of Local Law No. 2 of 2024 – Amending Sweden Town Code Chapter 73 Cemeteries; and

WHEREAS, all persons desiring to be heard were heard and due deliberation having been had.

NOW, THEREFORE BE IT RESOLVED:

Sec. 1. The Sweden Town Code Chapter 73 Cemeteries is amended as follows:

Chapter 73-1. Rules and regulations.

A. (3) In purchasing more than one grave, full purchase price must be paid for one grave and the balance shall be paid in full within 30 days or graves will be subject to resale.

(10) All full body interments during the week (Monday through Friday) must be in the cemetery by 2:00-1:00 p.m., Eastern Standard Time. After 2:00 p.m., 1:00 p.m., an overtime fee as set by the Town Board will be charged. No interment will be allowed after 3:30 p.m. 3:00 p.m., Eastern Standard Time...
(11) All interments on Saturday, Sundays and Town of Sweden observed holidays, including floating holidays, will be charged double the interment fee an overtime fee.

(15) All casket graves are required to have a concrete vault or liner. All fault setups, including Wilbert Ways, will be at the discretion of the Superintendent of Highways.

(21) No vault or mausoleum shall be above ground without the permission of the Town Board, and only in such locations as it approves.

(22) The Town Board will approve no mausoleum for construction unless a sufficient endowment is set up to provide adequate income to maintain the structure.

(24) Only one family monument shall be allowed on a plot. A minimum of six plots is required to allow for a family monument. All family monuments shall conform to established plan in regard to size, material, and location, *and must be approved by the Superintendent of Highways*.

- Sec. 3. The Town Board of the Town of Sweden herby adopts Local Law No. 2 of 2024 Amending Sweden Town Code Chapter 73 Cemeteries.
- <u>Sec. 4.</u> That the Town Clerk is authorized and directed to file a complete copy of Local Law No. 2 of 2024 with the Secretary of State, as required by law.
- <u>Sec.5.</u> This resolution shall take effect immediately.
