A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, October 22, 2024.

Town Board Members present were Supervisor Patricia Hayles, Councilperson Scott Maar, Councilperson Tyler Sharpe, Councilperson Adam Staskiewicz, and Councilperson Gary Sullivan. Also present were Finance Director Hiedi Librock, Highway Superintendent Brian Ingraham, Town Attorney Jim Bell, and Town Clerk Karen Sweeting.

Visitor present was Chris Hamlin.

Supervisor Hayles called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence to remember all of those in harm's way that are suffering from natural disasters, for those that are in war torn countries, and our first responders.

## PRIVILEGE OF THE FLOOR:

No comments.

#### CORRESPONDENCE:

No correspondence noted.

## REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Superintendent of Highways Brian Ingraham reported they are finishing County work on Salmon Creek Road. They are assisting the Town of Irondequoit, the Village of Brockport, and the Brockport Fire District (Owens Road). Flushing sewer systems, equipment maintenance, mowing at the cemetery and along roadsides, and preparing the Highway Department for renovations.

Councilperson Sharpe reported mowing continues at the cemeteries and the part-time seasonal staff should be done by November 18<sup>th</sup>. The Farmers Museum purchased an antique animal powered butter churn to add to their collection. The Cornell Cooperative programs have ended for the season. They are labeling and rearranging artifacts in the barn. The museum is looking for volunteers and will be participating in the Brockport Central School Pioneer Days.

Councilperson Maar reported the Seymour Library Board reviewed the 990s which are the not-for-profit tax returns from 2023. The Monroe County Library System is no longer charging for replacement library cards. Construction has begun on the bathroom remodeling. It has not slowed building usage and circulation is up 20%, strong numbers for programming and story times. The truck rodeo was a success – 150-175 in attendance. The Sweden Story Trail in the Town Park is going well. There has been discussion on ADA rules and dogs in the library. The library is looking into investing money in NY CLASS and reviewing some complexities with the program.

Councilperson Sullivan reported Buildings and Grounds are replacing the fence on Field #6, completed repairs, regrading and reseeding of Nietopski Field. Flag football is finishing, and soccer and baseball are done for the season. SUNY Brockport Baseball team will be redoing the pitcher's mounds. Justin Beach will oversee this project. The south parking lot near the dog park has been regraded. The roof on the outdoor building at the SCCC has been completed and

the siding will be done next year. Received recycled infield mix from SUNY Brockport for the fields at the Town Park.

Councilperson Staskiewicz reported that the annual Halloween event at the SCCC is scheduled for October 24<sup>th</sup>, the Veterans Day luncheon will be held early November. All programs are going well, and the recreation brochure will go to print soon. Early voting will be held October 26 – November 3 at the SCCC.

Supervisor Hayles reported that the Code Review Committee has been formed with the first meeting on November 5<sup>th</sup>. General Code Publishing will attend the second meeting on November 19<sup>th</sup> to detail the codification process. Mrs. Hayles has contacted the Sheriff's Department to discuss traffic and safety in the Town.

## PUBLIC HEARING

At 6:14 p.m. Supervisor Hayles called to order the public hearing. The purpose of the public hearing was to hear all persons interested in the budget, in favor of or against the Preliminary Budget for 2025, or any item therein to include the compensation to be paid to all elected Town Officials, pursuant to the requirements of Section 108 of the Town Law.

Supervisor Hayles waived the reading of the legal notice.

Supervisor Hayles presented the 2025 Budget which is under the tax cap by \$9,094. Particular challenges include reduction in mortgage tax, retirement contribution increases, minimum wage increases, and health insurance increases. This budget preserves all the current services. Mrs. Hayles detailed the services – some are required by law, others are optional.

Supervisor Hayles shared the categories within the budget and the budget summary (does not include special districts) – Town outside rate \$2.918 and Village \$2.4466. Mrs. Hayles shared the tax rate history for the Town, showing a decrease from 2024 to 2025. The total exempt valuation decreased to 37.28% due to the increase in assessed value.

Supervisor Hayles shared the special district tax rate summary. Only those that benefit from the district are taxed. The Clarendon Water District rate was just received. The Preliminary Budget amount was adjusted to reflect the current rate. Mrs. Hayles shared the statement of bonded indebtedness showing the amounts for each district.

Supervisor Hayles detailed the tax cap calculations. We are under the tax cap by an amount of \$9,094. The Town of Sweden amends the Preliminary Budget to reflect the current Clarendon Water District collections. The Town receives this money and turns it over to the Town of Clarendon. It does not affect our budget.

No other comments. The Public Hearing was closed at 6:38 p.m.
